Dear Mr Lamb

I refer to our email to you of 19 January 2017 following your letter to me of 17 January 2017 in which you raised a number of matters.

I can confirm that you are fully registered for 2017. Assuming of course that you comply with the processes for retention of your registration and continuing professional development, and that no professional conduct/fitness to practise concern arises that leads to your registration being restricted, I can see no reason why you would not remain fully registered throughout the year.

I have now had an opportunity to read the correspondence between yourself, the former Chief Executive and Registrar (David Howell), the Registrations Manager (Jamie Button) and the Acting Chair of Council (Roger Dunshea), including all the correspondence posted on the <u>www.justiceforautism.co.uk</u> website.

Your letter to me alleged that there has been a cover-up between the GCC, the BCA and Hertfordshire County Council over child abuse and breaches of rules, regulations and laws. I have seen no evidence of any cover-up involving the GCC. As the GCC has no remit with regard to the actions of the BCA or Hertfordshire County Council, it would not be appropriate for me to comment in relation to those organisations.

You also asked me to confirm that I have seen your letters of complaint to Mr Howell, Mr Dunshea and Mr Button, and requested confirmation as to the action I intend to take with regard to those matters. I can confirm, as stated above, that I have now read all the relevant correspondence.

In terms of my actions, the first step I would like to take is to ensure that I have correctly identified all aspects of your complaints (other than those which solely concerned the staff decision-making around your CPD submission, as that decision was later successfully appealed) and that I have correctly understood who each complaint is about.

I would therefore be grateful if you could review the table below and complete the third column (by hand if that would be easier for you than typing in your comments) to confirm whether or not my summary description of the nature of the complaint and the subject of the complaint is correct. If any of my descriptions are inaccurate/incomplete, I should be grateful if you could provide some explanation or additional detail within that third column of the table. I have aimed to include within the table not only the matters that you have raised as 'official' complaints, but also any other concerns that the correspondence shows you have raised about GCC staff/processes. You will see that I have included within the table references to the correspondence we have received from you that I believe may be relevant

- should you consider that I have omitted a significant piece of correspondence in relation to any particular issue, it would be very helpful if you could note that in the third column of the table.

I hope that reviewing the summary table and adding any comments to it will not be an onerous task for you. Having confirmation from you that I have analysed the key issues of your complaint accurately before I consider the next steps the GCC should take would be of considerable assistance to me.

I look forward to hearing from you.
