Dear Prime Minister Truss,

Congratulations on your new position. You are the third PM I have had to correspond with over the misunderstanding of autistic children and their special needs. They need diagnosing early so they are not put at risk, which is not happening at the moment. Many are being traumatised by the system who want children to behave normally, this is often not possible with AS. Then children do not thrive; they end up being labelled as naughty and then restrained when they melt down due to the pressure which they are put under by teaching staff who have not been educated to teach anything bar the norm.

Many have been repeatedly traumatised which does not help any form of normal development, and leads to isolation, depression, low self-esteem and virtually no education. I have covered much more in my series of letters to a won tribunal, General Chiropractic Council, Mrs May, Mr Johnson, and the cabinet secretary who will hold all the paperwork as requested.

My research shows that much of the problem goes back to short sharp shock which was introduced after the cane was banned and behaviour changed. Mr Blair severely cut budgets and changed the emphasis. Once the system was biased against these children they and their families were blamed with no rewards for naughtiness. Once the children have been traumatised, their home and family relationships degenerate. Then they are labelled by social services, often spiralling out of control, not engaging with anyone, stuck in fright and flight mode for years, burning cortisol causing mood swings, depression, and often bipolar symptoms.

You have several thousand locked up, often without diagnosis or charge, breaching their human rights; as seen by a case lost by the government. You have tens of thousands of mothers trying to protect their children, then fined when the child is kept of school. Many are drugged with adult medication to calm them down, but this does not address the lack of diagnosis and the correct treatment plan. The adult drugs affect the brain and emotional development which is not helpful.

The whole thing is an absolute mess. I have raised a complaint and asked for paperwork but have been ignored as your predecessor and others have covered up this abuse of vulnerable children with special needs - clearly not a vote catcher and costing billions to correct. I have gone through the process of complaint at multiple levels, and you cannot win. If there are no complaints then nothing is wrong; tick box all the way to the top. These people twisted the system to save money over decades and reside in the privy council. After all, it is much cheaper to do nothing with complaint a nonstarter, than spend billions on naughty children and their bad mothers who have no voice. I have repeatedly asked for an independent investigate with no success, which means more undiagnosed children are put at risk and damaged further by the system.

Any help you can give me to find justice will in turn help these children to develop and prosper. How is this cover-up possible in a transparent democracy? It will be a question for the ICC in time if I get no response. The mother of Child X holds all the proof in the paperwork, and I have a 12-year case study chronicling all that happened. So far nobody is interested in the truth.
