To whom it may concern,

I accuse the British government of crimes against humanity. My name is Howard Lamb DC. A Doctor of Chiropractic of consultant status with a 40+ year clean record. As a family practitioner and filling the gaps from the normal system, I have treated and improved the lives of spectrum kids, and those with cerebral palsy or traumatic brain damage. Unfortunately, my free clinic had to stop with the pandemic. That is, all but one case study on child X. As his family's mentor, I have been directly involved for 14 years.

In that time, I have seen and learned much. This child was purposely put at risk, traumatised, and blamed as a naughty boy rather than being diagnosed with high functioning autism, ADHD and dyslexia causing learning difficulties, to save money. Much of the information about this is up on the internet via my Justice for autism website. The rest and solid evidence are with the mother, who holds all the paperwork, not just on child X but her journey through the hell her family have gone through. After first contact, the mother will send you two bundles of paperwork. The calculated abuse of her child and how the council treat naughty families.

Through my clinic and when on the ground with this child, I have come across multiple families going through the same. It's an integrated system throughout the nations, without diagnosis you are treated as normal, when you are not. One on one to engage with the child. Special needs schools. In fact, a whole infra structure needed to be put in place. Much cheaper to blame the child after all. The children's human rights have been suspended so they can be bullied and restrained, imprisoned without charge, sent to care homes often hundreds of miles away and brain washed into normality, which does not work on autism. Leading to post traumatic stress and long-term mental health issues, culminating in prison or suicide and in many cases, both. They leave care at 18, unable to fend for themselves and not housed. With limited education and mental health issues, their future is bleak.

It is impossible for the system to have failed these lost children unless the system had been perverted at the very top, into the privy council and crown offices. If you remove human rights and class these kids as subhuman, with no access for complaint. Who is going to speak up for them within the system.

I have been through their system at multiple levels, which have not followed its legal path regarding complaints procedures, denying paperwork. Breaking transparency, disability, and equal opportunities laws on the way. A clear cover up as it is commonplace. Many kids are never diagnosed and are traumatised by the system. Many others get diagnosed but no help is given. Many get diagnosed after 18 when not the government's responsibility anymore.

I am still waiting for a response from the IOPC. I will forward it when it arrives. I believe a simple DNA test at birth would diagnose many when the surgeon general did not want any diagnosis before aged 6. Just in case the grew out of it. Yet early diagnosis and understanding is key for these kids to develop without being traumatically stressed.
