To the Right Honourable Sir Keir Starmer KC.

Dear Prime Minister,

I have written on numerous occasions to you and your predecessors regarding the systems abuse of children through non and wrong diagnosis. Without correct diagnosis it is impossible to put in place the correct treatment plan. Children who do not fit the norm are often coerced, bullied, restrained and isolated until they do.

Many are wrongly removed from their families which only isolates them further. Mostly, they are all in fright and flight mode, spiking cortisol and damaging the hippocampus, and altering the normal chemical brain reactions. These reactions in the juvenile brain will often alter brain function for life and ultimately causes depression, lack of self-worth, and an inability to function normally in relationships - a long list.


In the process of ignoring me, you and others have breached protocols, standard procedures, an Act of Parliament, and laws, which I have pointed out in previous correspondence. It is not the children's fault that government after government has used non diagnosis to restrict budget and save money. Clearly if you do not diagnose them, you do not need extra expensive staff and facilities. However, ignoring their plight only compounds their abuse by a system which does not cater for their needs. You are the head of that system and are accountable. Unfortunately, the system is so corrupted that all complaint is ignored or suppressed. I have personally seen this and have all the proof in the paperwork as part of my case study.

It is assumed as an honourable gentleman you would do the right thing, but you have not, in-fact you seem to have made their lives worse. You clearly have not wanted to deal with this situation, as seen by lack of feed back to my multiple communications, yet you have a duty of care that goes with your titles. Please explain why!

My interest in this subject is only to improve those with neglected neurodivergence and actually improve their chances of a fulfilling life, paying tax and interacting well in society.

Important low-cost changes can be made. Education of staff and families for starters. Once you understand why the children react like they do, they can be handled better, breaking the constant cycle which causes them so many problems now.
